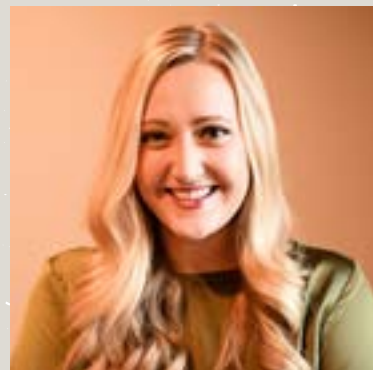

Our annual report has become a piece that shares your gifts to Kentucky FFA, the impact we have made in the lives of our students, and a historical record of what we have achieved together.

I will remember 2023 as a year where we positioned the Kentucky FFA Foundation to grow tremendously and sustainably to support the next generation of agriculturalists in bigger and more meaningful ways than ever before.

It was the first year with Ruth Ann Fink on the team as our Development Officer and she did an incredible job. She overhauled our State FFA Convention sponsor experience, executed a fantastic Blue & Gold Gala, and built our new program, Kentucky FFA Works from the ground up. Our Stewardship Coordinator, Ashley Weaver, takes care of all the details that make for a good giving experience and keeps us organized. It's truly a team I'm so proud & humbled to lead.

We began the year restructuring the Kentucky FFA Foundation Board of Trustees. This is a daunting task, but a healthy board of trustees ensures that the dollars given to the Kentucky FFA Foundation will be stewarded well for generations. I look back on the incredible folks who have served on our board and I stand in awe of the time and talent people have given to us because they believe in our mission and vision. We are often paid the compliment that our board is the most well-run, committed, functional board with which a sponsor has worked. That's a testament to the talent and professionalism FFA produces.

We also finalized a Strategic Plan for Kentucky Ag Ed this year. The Kentucky FFA Foundation took the lead in bringing all our stakeholder groups together. We made a road map to help us navigate and position ourselves

to prepare future leaders in agriculture, ready to meet the challenges this generation faces. If you have ever worked on a strategic plan, you know it's difficult. The fruits of that labor are already paying off as we are putting this plan into action.

The last quarter of 2023 was spent working on brand new projects that launched in 2024. We are thrilled to introduce our podcast, *Growing Kentucky's Leaders*, to the world! Ruth Ann and I share conversations with our students, donors and teachers about how FFA has impacted their lives. We discuss leadership, vision and philanthropy. It's been so fun to tell the story of Kentucky FFA in new and exciting ways.

We also launched Kentucky FFA Works, a hiring solution for our supporters. This initiative was born out of our Strategic Plan. It's our hope that we recruit and retain all graduating FFA members who are ready for the workforce into the agriculture industry, working for companies that support Kentucky FFA. I hope if you make hiring decisions for a company you'll join us.

I mean it when I say that I am more excited about our work and where Kentucky FFA is going than ever before. We aim to offer the greatest agricultural education experience in the country and we need your support to do that. I hope you'll be inspired to grow alongside us!

DEAR SUPPORTERS,

We have so much to be proud of as the Kentucky FFA Foundation. Just a few years ago our annual budget was around \$500,000 and this year our approved budget is nearly \$1,500,000; a 300% gain. Our endowment now exceeds \$7,000,000 including nearly \$1,500,000 in the Forever Blue fund, which didn't exist seven years ago.

None of this is possible without our supporters. From the individual who contributes \$5 a month to our Distinguished Star Partners, every dollar helps some student live their dream; be that a blue corduroy jacket, a trip to FFA Camp, a beehive for an SAE project, a convention award, or a Shark Tank grant.

WE ARE BUILDING ENTREPRENEURS! WE ARE BUILDING LEADERS! WE ARE SUPPORTING TOMORROW'S AGRICULTURALISTS!

BUT THERE IS SO MUCH MORE TO DO.

- We had 457 applications for SAE Grants this year, but could only award 165.
- We had 36 students apply for our Washington Leadership Conference Scholarship but we could only award 15.
- We had requests for over \$100,000 in Ag Achiever Grants; funds we offer to enhance agricultural education classrooms, and could only fulfill \$50,000 of the need.
- We only awarded jacket grants to 67 FFA Chapters.
- We had 13 students apply for our Shark Tank grant and only three could receive the full \$5,000. Five other finalists received \$1,000.

We have all seen the results of our work and we are all aware of the impact that more resources could have on more students.

I urge each of you to consider doing all you can so we can expand our giving and help more of our students. If you know of others we should be asking for help, tell us. There are lots of ways to give and lots of need for the gifts.

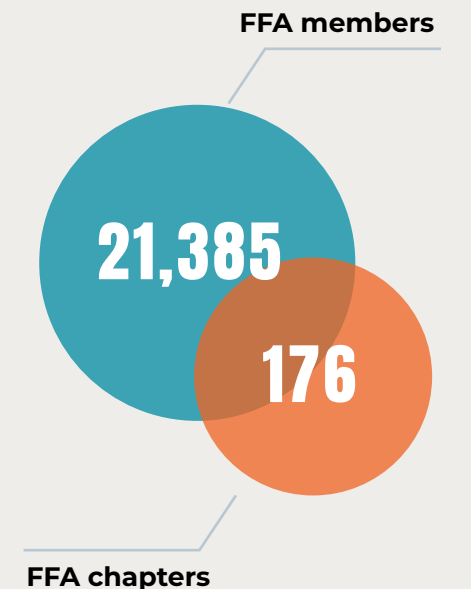
SUPERVISED AGRICULTURAL EXPERIENCE

STATE STAR FARMER

Jeffrey Sprowles, Taylor County

Jeffrey started his SAE in 2019 by growing 5 acres of soybeans and an acre of strawberries. Since then he has expanded his operation to include corn, wheat straw and soybeans.

In 2022, he sold more than 4,400 bales of straw to local customers, including Southern States and the local water company. Jeffrey has exchanged labor with his family for use of equipment and has cash-leased farmland. He has learned to make management decisions including variety selection, and scouts his crops regularly to determine the need for pesticide and fungicide applications.

Jeffrey is the son of Scott and Jennifer Sprowles. His FFA advisors are Ryan Williams, Lindsey Wayne and Ryan Hunt. The State Star Farmer award is sponsored by Farm Credit Mid-America.



STATE STAR IN AGRIBUSINESS

Morgan Shipp, Williamstown Independent

Morgan became co-owner of the Washrack Equine Laundry Service in 2019. In addition to washing and repairing horse blankets for customers, she began waterproofing blankets and horse tack.

The business requires strong communication skills and careful record keeping to ensure customers are billed correctly. A reputation for quality work and good customer service have helped Morgan grow her business over the past 4 years. She continues to look for additional services that she can provide as part of her business.

In total, about 2,100 students use the Leadership Training Center each summer. This includes five weeks of FFA Camp for high school students and a Middle School Camp experience, which together bring about 1,700 FFA members. Also, about 400 additional guests will use the Leadership Training Center each summer for their conferences and meetings.

"Of all the factors that make a summer camp successful, mattresses might not be the first one that comes to mind; but the impact on the energy level at camp by a good night's sleep is very important," said Josh Mitcham, the camp director of the Kentucky FFA Leadership Training Center.

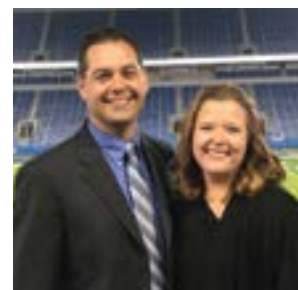

Lyon County alumnus Joe McCarty made a major contribution the Lyon County Forever Blue Endowment in honor of his former ag teacher, Mr. Stanley DeBoe.

McCarty credits Mr. Deboe for being a major influence in his young life, and wanted to create a scholarship in memory of that positive impact.

His contribution made possible the \$1,000 Lyon County FFA Scholarship, which will be awarded each year to a Lyon County student who demonstrates leadership and academic achievement.

"Mr. DeBoe had this innate ability to bring people together," said McCarty. "You just wanted to be around him. He was the glue that made everything stick together."

It is a privilege for the Kentucky FFA Foundation to steward the gifts of those who want to pay forward the great things they experienced through FFA. The Forever Blue Endowment fund is making that possible.

The State Star Farmer program recognizes the student with the top agricultural production SAE in Kentucky, and the State FFA Degree is the highest degree a member can earn at the state level.

GIVE FFA DAY CHANNELS GIFTS DIRECTLY TO YOUNG ENTREPRENEURS

Held each year on the Thursday of FFA Week, Give FFA Day encourages anyone who has ever been impacted by the positive power of Kentucky FFA to make a donation.

2023 gifts were used to provide SAE and Shark Tank grants for current FFA members.

Thanks to 153 donors and a generous matching gift from Owensboro Grain, Give FFA Day 2023 raised \$32,752.



WE AWARDED A TOTAL OF \$102,000 IN SAE AND SHARK TANK GRANTS IN 2023.

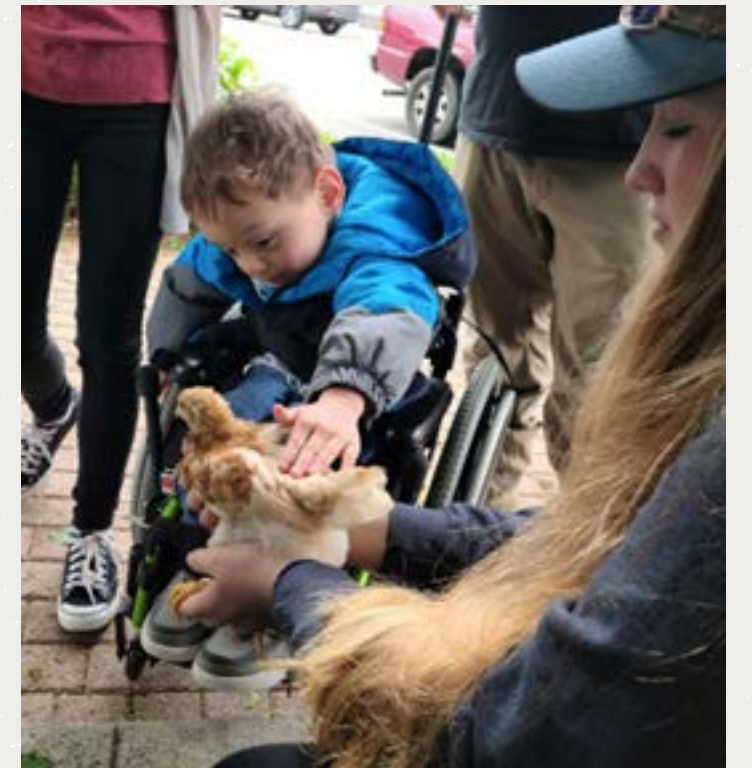
Funds for SAE and Shark Tank grants came from Give FFA Day, Mulhollem Cravens Foundation, First Southern Bank, Central Kentucky Ag Credit and the Steele Reese Foundation.

Members use these grants to start or expand their entrepreneurial SAE projects. Funds can be used for equipment, materials, training, or other costs.

Cameron Huggins of the Simpson County FFA Chapter used her SAE grant to expand her poultry SAE and egg production entrepreneurship “Huggins’ Hens.”

Cameron has several SAEs where she advocates and educates about the poultry industry. She combined two of her projects — donating eggs to local elementary schools for hatching and conducting educational activities around this.

As part of this work, Cameron wanted to hatch her own fertilized eggs at home. Her grant will be used for an incubator and other supplies needed to hatch chicks.



BLUE & GOLD GALA

This year's Blue and Gold Gala raised a NET of more than \$185,000. Those funds have already been put to good use for scholarships to WLC and FFA Camp, as well as for Ag Innovation Chapter Grants, FFA Jacket Grants and more!

EXPLORE YOUR GIVING OPTIONS

If you are interested in making a gift to the Kentucky FFA Foundation, you have many options for making an impact that best fits your unique situation.

GIFTS OF CASH

The majority of gifts to the Kentucky FFA Foundation are in the form of cash. If you itemize your tax deductions, you may claim as a charitable deduction a cash gift of up to 50 percent of your adjusted gross income.

GIFTS OF SECURITIES

Gifts of appreciated securities can provide special tax advantages: you may completely avoid capital gains taxes; and the fair market value of the stock may be claimed as a charitable deduction on your income tax, up to 30 percent of adjusted gross income for those who itemize, with a five-year carryover.

The simplest way to make a gift of stock is to instruct your broker or banker to transfer it to the Kentucky FFA Foundation. The broker should then contact the Kentucky FFA Foundation for further instructions.

GIFTS OF REAL ESTATE

Gifts of homes, farms, and other real property can receive the same tax treatment as gifts of securities: no capital gains tax plus deductibility at fair market value. If this is appealing to you, please make plans to discuss intent and restrictions with the Kentucky FFA Foundation.

GIFTS OF LIFE INSURANCE

When you name the Kentucky FFA Foundation as the owner and sole beneficiary of a life insurance policy, you receive an immediate income tax charitable deduction for the lesser of the policy's fair market value or the net premiums paid. Premiums you pay later are also tax deductible.

MEMORIAL & HONOR GIFTS

You may designate gifts to remember or honor a relative or friend for a specific purpose, or you may allow the Foundation to use such gifts for general support. Acknowledgment will be made to the family of the deceased if the name and address of the closest survivor is provided.

MATCHING GIFTS

Some are able to increase their gift to the Kentucky FFA Foundation by employer matching. If your employer has such a program, your gift may be multiplied once, twice, or even three times. Usually, your employer's personnel department can provide information about a matching gift program and forms to send with contributions.

ESTATE & PLANNED GIFTS

Although outright gifts provide valuable support for current programs, estate giving provides substantial support for future programs. This form of giving is particularly suitable if you desire to make a larger gift through your estate rather than in your lifetime. The allowable estate tax deduction for charitable gifts remain unlimited under the new tax laws.

WILLS

The most common form of an estate gift to the Kentucky FFA Foundation is a specific bequest in a will. You should arrange to draft your will with your attorney. Foundation staff are available upon request to confer with you and your attorney in drafting the appropriate bequest clauses.

GIFTS IN TRUST

If you wish to receive income during your life and at the same time provide a significant gift to the Kentucky FFA Foundation, you should consider establishing a charitable remainder trust, that is, a life income trust.

GIFTS-IN-KIND

Another way to support the Foundation is through gifts of tangible personal property.
